### Overview

### Notable Experience Snapshot

- *Shell v. Robinson*, No. 01-1417, United States District Court for the Eastern District of Louisiana, obtained a complete victory in a bench trial on misappropriation of trade secrets from an employer by an employee. Successfully secured an injunction against the defendant for use of property which belonged to the plaintiff.
- *Kieta Alexander v. Norfolk Southern Corporation*, et al., No 02-14666, Civil District Court for the Parish of Orleans, obtained a complete victory after bench trial in a mass toxic tort trial involving 2900 plaintiffs that was tried for several weeks in Civil District Court after the other defendants settled. The judgment dismissed all claims against our client, finding that it had no liability for a chemical release that occurred in New Orleans.
